



How to Sign up for E-Statements

NOTE: You will need to have access to No-Line banking and a verified email address in order to sign up for E-Statements. If you do not have a username and password to access No-Line Banking, please call us at 512.444.6419.

1. Log-in to No-Line Banking by clicking the “Go” button at the top right of Austin FCU’s homepage. You will enter your username, answer your security questions and enter your password. If it’s your first time logging in, see the “Helpful Links” section of our website for a tutorial of how to log in.



2. Within No-Line banking, click “Statements” in the bar on the top of the page. Click “Click to sign up!”



We have not yet verified your e-mail address. Please check your inbox and spam folders for a message asking you to verify your e-mail address, and follow the instructions contained within. You will be unable to enroll in E-Statements until you have completed this process.

If you receive the message to the right, you will need to verify your email address before continuing. See “Helpful Links for a tutorial on how to do this. If your email is already verified, continue to Step 3.

3. On the next page, review the disclosure. You will need to enter the numbers you see in the white box into the Verification Code text box highlighted in red below. (If you can’t see the numbers in the box, click the link to download the latest version of Adobe.) Once you have reviewed the disclosure and entered the verification code, select the “I agree” radio button and click continue.

Federal law requires that we provide important information to you regarding e-notices and e-state receive your periodic statements as well as account notices electronically. You may print or download statements or notices for future reference.

To receive your periodic statements electronically, you must carefully review the following terms:

1. This consent applies to your periodic statement and e-notices only. All other disclosures and notices will be in writing unless you and we agree otherwise.
2. You may withdraw your consent to receive electronic periodic statements and e-notices at any time.

4. Done! You are officially signed up for E-statements. In order to view your statements you will select the statement you wish to view from the drop down and click "View E-Statement."


